

Chapter 57

Carpets and other textile floor coverings

Notes.

1. For the purposes of this Chapter, the term "carpets and other textile floor coverings" means floor coverings in which textile materials serve as the exposed surface of the article when in use and includes articles having the characteristics of textile floor coverings but intended for use for other purposes.
2. This Chapter does not cover floor covering underlays.

Explanatory remarks to Chapter 57

The exportation of carpets and rugs of a kind made wholly or in part of artificial fibres and those woven of yarns dyed with sub-standard dyes, as well as those having artificial fibre warp and weft is prohibited.
